Antimatter and Gravity

Gabriel Chardin In collaboration with Mathieu Agelou

What if antimatter fell upwards rather than downwards? With Gabriel Chardin, take a look at this theory in the making, for a new cosmological model.

Cosmology is the branch of physics that deals with the Universe. It is concerned with its most minute components as well as its most colossal structures, from its birth 13.8 billion years ago to its final moments in a future yet to be determined. To think about an object of this kind, we have to make simplifying hypotheses, which are brought together in mathematical models. But the current standard cosmological model, based on Einstein's theory of general relativity, is in crisis.

To account for what we observe, we keep adding hypothetical elements, like patches. For the moment, we can't explain the movement of galaxies without assuming the existence of so-called "dark matter", nor the speed of expansion of the Universe without "dark energy", and while we know that in the first instants of the Big Bang there was as much matter as antimatter, we don't know where the latter has gone, as it is only observed very briefly and in tiny quantities in our particle accelerator. For decades, Gabriel Chardin has been building an alternative model that would solve these problems. If we assume that antimatter "antigravitates", i.e. that it repels everything and therefore "falls" upwards, then we no longer need to suppose the existence of dark matter or energy, and this antimatter would not have disappeared but would be found, extremely diluted, almost everywhere in the Universe.

This model, taken very seriously, is currently being tested at CERN, where attempts are being made to "weigh" anti-electrons. The first partial results were published in September 2023, and the experiments will continue.



A Brief History of Cosmology

Françoise Combes

From Ptolemy to the James Webb telescope: discovering the universe and its galaxies.

Cosmology is the science of describing the Universe and tracing its history through time. Until the early 20th century, the observable Universe was limited to our immediate vicinity: the planets and their erratic motions, the stars, the white band of the Milky Way, and the "nebulae", extended luminous zones. We had already understood a number of essential things (that the Earth was round, as early as 500 BC; that it revolved around the Sun, with Copernicus; that all body movements were due to gravitation, thanks to Newton), but we remained very limited, unable as we were to determine the distances of all these objects. It was a woman, Henrietta Leavitt, who in 1909 made the discovery that certain variable stars could be used as "standard candles", i.e. as distance indicators. And then, surprise: some objects, like Andromeda, are far too distant to belong to our Milky Way. The Universe became immense, and our galaxy one among an infinite number of others.

From then on, the story accelerates, and one discovery follows another: the Universe has an origin, the Big Bang; it is expanding; the rotational movements of galaxies cannot be explained without the involvement of invisible matter of an unknown nature, known as dark matter; far from slowing down, as expected, the expansion accelerates, proof that energy, also unknown, is being introduced. So many pieces of a puzzle being assembled in competing models, so many answers beckoning new questions. A story told by one of its leading figures and best specialists, Françoise Combes.

Colors of Life

Jean-Michel Gibert

A richly illustrated book showing the variety of colors in living things, their functions and how they appear.

The green of leaves, the red of a poppy, the pink of a flamingo, the blue shell of a lobster, but also spots and stripes: the living world explodes with colors and patterns.

They can be used to hide, or on the contrary to display toxicity. Male birds may use them to attract females, and flowers to attract pollinators. Ripe fruits are colored to make them easier to spot by those who eat them, and thus help spread their seeds. Pigmentation can also serve to protect against UV rays, or, in the case of certain insects, to modulate body temperature: darker individuals warm up faster and are more active. Zebra stripes disturb flies, while cheetah spots mimic the intermittent light of undergrowth.

The variations are infinite, but the genesis of colors and their patterns is governed by the laws of genetics and the environment. This is what this book invites us to discover.

The Secrets of the Deep Sea Edited by Sophie Gambardella, Pascale Ricard, Séverine Martini

An illustrated book, somewhere between a comic strip and a popular science book, about the deep sea. Too often perceived as a new Eldorado, it needs to be protected.

The deep sea includes everything below 200 meters below the ocean surface, from the water column to the soil and subsoil. Covering three quarters of the Earth's surface, it represents an immense space. While the average depth of the ocean is 3,800 metres, it can reach over 10,000 metres!

Knowledge of the deep sea and an understanding of how it function are essential for a number of reasons, both to demonstrate its richness and to better understand its contribution to human society. However, this requires us to rethink a number of preconceived ideas. The deep sea is not a big black hole where nothing happens. Although deprived of sunlight, these depths are inhabited by a multitude of species and are home to a rich underwater biodiversity that is still largely unknown. They also represent one of the planet's main carbon sinks, as it is in the seabed that the residues of carbon captured at the sea surface settle. It is also here that some hope to find a partial solution to the energy transition, thanks to the presence of numerous metallic resources... but this is not without raising a number of questions. In short, the deep sea undoubtedly holds many surprises.

What should we make of the removal of books by Russian authors from Ukrainian libraries?

While shedding original light on the war in Ukraine, this book also suggests ways of putting a number of contemporary debates into perspective.

Statues debunked, Russian artists de-programmed, works of art ostracized: after the outbreak of large-scale war in Ukraine in 2022, Russian cultural objects sometimes found themselves in the hot seat, accused of having been a link in the genealogy of violence. This book seeks to understand why, in the context of war, culture has found itself on the front line.

How is it that art suddenly seems to be the shadow of power? Why do we suspect that "great Russian literature" might carry an ideological message? What does the war in Ukraine reveal about the construction and valorization of the social, political and existential functions of these works?

A History of Dietetics


From Hippocrates to the Nutri-Score Bruno Laurioux

What is recommended to eat and drink, when, under what circumstances and for whom? From Atiquity to today, Bruno Laurioux studies the history of dietetics, reflection of the desires, fears and representations of an era.

Today, dietetics is everywhere. This practice, often associated with modernity and contemporary concerns, actually has a long history. It dates back over two thousand years. While dietetic discourse has evolved considerably over time, food has always held a central place.

As far back as Antiquity, we find lists of foods with their medical properties, and specific diets designed for particular illnesses, seasons or even individuals, in order to heal themselves or maintain their bodies in an optimal state of health. From one century to the next, a food's virtues were transformed into vices - meat and sugar being emblematic of these reversals of discourse.

By combining intellectual and social history, we can understand the origins of some of our consumption patterns: why was it that melon, long considered very dangerous, had to be eaten at the beginning of a meal, accompanied by a glass of strong wine? But also, what are the complex relationships between vegetarianism and various religious reform movements or anarchism? Or how has the calorie become the tool for a quantification of nutrition that is properly political? Dietetics is an eminently cultural object, because it is part of the evolution of a society to which it must also adapt.



History books, often focused on great men and national heritage, generally overlook an invisible but powerful player: germs. Yet these tiny organisms have played a decisive role in the destiny of human societies.

This book tells the story of the contagious diseases that, from tuberculosis to influenza, smallpox, the plague and cholera, have emerged over the centuries to redraw the map of the world. Germs offer a unique perspective on our history, influencing the rise and fall of cities, deciding the outcome of wars, shattering entire civilizations and erecting barriers that even the most powerful empires could not overcome. African diseases, for example, were a formidable obstacle to European colonization, while European epidemics decimated Native American populations, paving the way for the conquest of the New World.

This book also explores the way in which epidemics were perceived and recounted, and the reactions they provoked: medieval quarantine measures, prevention campaigns by colonial medicine, social and political upheavals... right up until the beginning of the 20th century, when science began to lift the veil on our invisible enemies.

The Spanish flu, which appeared in the wake of the 14-18 war, can thus be considered the last pandemic before mankind had the tools to try and prevent it.



The United States acted as a colonial power over Native Americans. This book takes stock of U.S. policy towards indigenous peoples, from the 18th century to the present day.

Indianness survived the Conquest and colonization. The continuity of this identity is a heroic epic that runs like a thread through the history of the United States. This book analyzes the complex interactions, alliances and revolts that marked relations between the Indian nations and the American government.

Faced with the Indian presence, of major importance in the early days of Independence, then gradually overshadowed in the name of Manifest Destiny, the role of U.S. presidents varied, more or less benevolent or hostile, often hesitant, sometimes decisive.

Since the 1930s and Franklin D. Roosevelt's New Deal, a process of renewal has been underway: territorial recognition, demographic recovery and participation in the struggle for civil rights. The alternation of progress and reversals has made this process a long, exhilarating and determined march.

Occupied Constantinople (1918-1923)

Constantinople, cultural capital in full effervescence: the roaring twenties alla turca.

At the end of the First World War, from 1918 onwards, Istanbul was occupied for five years by the Allied forces: the French, the British and the Italian. A garrison city, it was also a city of repression for the population undergoing the first foreign occupation in five centuries, but also a city of rediscovered freedom for minority groups. 

The Origins of Arsène Lupin's Character

Ostrowski, an « hotel rat » at the Belle Epoque Patrice Lajoye

At the heart of the wealthy society of the Belle Epoque, this investigation recounts the story of the man who inspired the character of Arsène Lupin.

The end of the 19th century saw the emergence of a new phenomenon: tourism, and in particular seaside holidays. With it came the opening of grand hotels and palaces all over Europe, reserved for a wealthy clientele: the old nobility and the new industrial bourgeoisie. This concentrated luxury in places open to the public soon attracted a new class of thief: the hotel rat. Despite their unflattering name, they were high-class criminals: although they came from working-class backgrounds, they were cultured, multilingual and well-presented. They operate by renting a room before spending the following nights robbing their neighbors, then leaving as if nothing had happened. They were never violent and strived to be as inconspicuous as possible.

Georges Ostrowski is one of them. Born in the Ukraine, a Russian citizen, he was active for some forty years, notably in Germany, where he was the "Black Ghost of the Kaiserhauf", but also in England, Italy and above all France. Known to European police forces and once hunted down by a commissioner of the famous "Tiger Brigades", he remained remarkably discreet, to the point of appearing nowhere in the history of crime. Nevertheless, he had a profound and lasting influence on twentieth-century popular culture, and was the little-known inspiration behind Arsène Lupin and Fantomas.

Patrice Lajoye tracked down the slight traces that this true chameleon, who changed identity with each of his trips, left behind him: police report, interrogation report, a few letters, and above all an extensive press kit.


Ibn Khaldoun

Itinerary of a Maghrebian thinker Mehdi Ghouirgate

The biography of a major figure in the history of thought, by a historian of the medieval Maghreb.

Since its rediscovery in Europe two centuries ago, the fame of Ibn Khaldoun (1332-1406) has continued to grow, to the point where today he is the only thinker from the Arab-Muslim world to have a universal audience. The author of the monumental *Kitâb al-ibar*, or *Book of Examples*, is compared with the great names of Antiquity and Modern Times, from Thucydides to Machiavelli, Montesquieu and even Marx. He has earned the reputation of having been the precursor of just about everyone who has dealt with society, the state, economics or the philosophy of history since the 18th century. To go beyond the romantic figure of the lonely "genius", this study sets out to trace the career of this writer in a period marked by the Black Death and the failure of the Merinid sultan Abû l-Hasan to unify the Maghreb. It traces the peregrinations of the man who was initially a practitioner of power in the courts of the Muslim West - Tunis, Fez, Granada, Bougie and Tlemcen - before his exile to Cairo, then the most brilliant city in Islam, where he devoted himself to teaching and a career as a magistrate.

In this way, this book sheds light on the conditions of formation of his theory of civilization, and in turn allows us to question the modalities of the construction of an idol, in the Muslim worlds and then in the West.



The Amazon River

For the river's immense basin has been, and still is, much coveted. Firstly, by the colonial empires of Spain and Portugal, each of which appropriated a share of this space, often to the disdain of the indigenous peoples. Today, nine nation-states are very attached to their territorial hold, including Brazil, which owns two-thirds of the region, and France, which has a presence there thanks to French Guiana. Conflicts have not disappeared, particularly between local populations and settlers from neighboring cities (or even other continents) who have come to extract oil, raise cattle or plant soybeans.

While the Amazon River was at the heart of all regional activities for more than five centuries, the sudden irruption of roads and massive urbanization from the 1960s onwards completely changed the situation. What new divisions are taking place today? How can we preserve this river from the excesses of humanity?

When the West Takes over the World (15th-21st centuries)

Is It Possible to Modernize Without Being Westernized?

Maurice Godelier

A re-reading of the birth and rise of the modern world by a major figure in contemporary anthropology.

If modernization is a social phenomenon of borrowing which has taken many forms in the course of history, it must be noted that the West, since the 15th century, has imposed itself - often by arms or by propaganda - as the model of modernity. Voluntarily or not, hundreds of societies have been transformed under its influence, so that, for the first time, all of them have entered into the framework of a common history. But what were the different modalities of this vast mutation? To what extent have certain societies been able to integrate themselves into this overall movement while retaining specific traits, different from, or even opposed to, what was promoted by the West? For it is possible being westernized without becoming Western. And how can we distinguish between irreversible transformations and those that can be challenged today?

For a long time, the belief in progress led people to believe that economic development, the evolution of morals and political democratization went hand in hand. The collapse of this myth now allows us to better characterize what has really been at stake in the globalization driven by industrial capitalism, and thus to understand the challenges that await Western societies today, which are faced with exacerbated hostility and may be on the verge of losing the economic, political and military leadership that has fueled their expansion.

An outdated spectacle, a place of exploitation, zoos have been attracting criticism and controversy for the past decade. And yet, despite declining attendance, zoos remain a must-see destination for tourists from all over the world. But what's so special about the zoo? What today justifies the confinement of such "denatured" animals?

In the zoo, life springs forth and is controlled, animal beauty emerges and is represented, the wild is irreducibly part of the domesticated. In turn specimens, merchandise, ornaments, relics and gene banks, animals are first and foremost desired for their living presence. The power of the possible encounter, in unparalleled conditions, runs through the zoo project, explaining the wonder and controversy it arouses. How to capture animal life? How do we present the wild without absorbing it? How can we interest them in our presence and, in return, teach them to be affected? How to confine and safeguard?

This long-term investigation, carried out with the caretakers, visitors and animals of nearly sixty zoos, shows that they are not just a place for exploitation, nor for the conservation of the future, but above all for breeding, i.e. for living together. Zoos are troubled by the tension they constantly exert between life and death, joy and regret, wild and domestic.

Trance

An Investigation into an Altered State of Consciousness



Could trance, like hypnosis, be a therapeutic tool? An investigation conducted within a network of researchers aiming to study the medical potential of this practice.

Trance: behind this blurred, polysemous term lies a common, universal and ancestral phenomenon. Stripped of its cultural, ethnological or mystical trappings, trance is said to enhance our cognitive, psychic and organic potential. This was the discovery made at the dawn of the 2000s by French ethnomusicist Corine Sombrun, after experiencing a spontaneous trance during a shamanic ceremony in northern Mongolia.

On her return, she enlisted the help of neuroscientists to examine what, at the cerebral level, induces the phenomena of trance: an increase in physical and mental power, analgesic effects and soothing sensations. Like the states of meditation and hypnosis, which have been examined and tested by science and medicine, trance thus appears to be a therapeutic tool that complements standard care: it could soothe certain pathologies (psychiatric syndromes, stress, addictions), make treatment more bearable, or improve certain skills (concentration, physical power, agility, logic and rationality).

But for this to happen, academic research needs to get to grips with the subject and produce formal, phenomenological and clinical proof. This is the ambitious and daring objective of a network of researchers, doctors and health professionals, who are taking trance out of its esoteric envelope and establishing it as a pure object of scientific study. As a science reporter, Céline Loozen spent two years at the heart of this emerging discipline, examining its aims and methods.

The absence of a project is a pathology of our contemporary world. And yet, being able to picture yourself is essential to our very existence.

"Project-based management", "political project", "project financing": the project device is at the heart of contemporary capitalism. Designed to get subjects more involved in the tasks assigned to them, it paradoxically contributes to reducing their capacity and desire for projection. This loss of momentum, this "deprojection", creates a feeling of powerlessness. If we stop projecting ourselves, we leave it to others to design our world, with major social and ecological consequences.

Amaena Guéniot examines the conditions that will enable us to regain the power to project ourselves together in the long term. Drawing on Marx's critique of capitalism, Arendt's reflection on human activity and Foucault's analysis of power, she deconstructs capitalist project structures - project-marketing, project-employment - and explores ways of redirecting production towards more desirable ends.

Through a philosophical analysis informed by the social sciences, the author sheds light on the causes of deprojection and the possible levers of emancipation. She proposes new institutions that can guarantee individual and collective subjects the resources and time they need to shape their projects.



The Birth of Marxism

Germany, Russia, USSR Guillaume Fondu

An original historical and philosophical study that rediscovers a vast and forgotten literature. It brings to light the tensions at the heart of Marxism and, more broadly, the social sciences: how can an understanding of society and its history lead to its transformation?

Like most terms derived from proper nouns, "Marxism" was first used to stigmatize supporters of Marx's ideas, reduced to worshippers of his person. The word was also often used in opposition to the figure of the inspirer, to open the way for a possible return to Marx without having to worry about Marxism (defined at the time as "a set of misunderstandings made about Marx"). Unlike the many mobilizations that seek to oppose the vitality of Marx's individual thought to a necessarily "dogmatic" Marxism, what is at the heart of the interrogation here is what makes Marxism as such interesting: the pursuit and concretization of a discourse inspired by Marx in contexts quite different from the one that presided over the genesis of his work. The analysis focuses on three constituent moments: Germany at the turn of the 19th and 20th centuries, Russia in the early 20th century, and the Soviet Union in the 1920s. Reconstructing the contexts and issues at stake in the different readings of Marx, the investigation takes as its common thread the question of the performativity of discourse, of the link between reflection and action, the tension between which remains a crucial issue for all social science.



With a doctorate in philosophy and as a recognized specialist in Marxist studies, Guillaume Fondu has edited the anthology Facing the revolution. Political debates and struggles in 1917 (Les Éditions sociales, 2017) and is contributing to the re-edition of Karl Marx's works by Les Éditions sociales.





French Design

Two Centuries of History Stéphane Laurent

Charlotte Perriand, Philippe Starck, Le Corbusier, Moulinex-Seb, Yves Saint-Laurent, Hermès: Stéphane Laurent recounts two centuries of French design, between creators and entrepreneurs, art and functionalism.

Joseph Opinel's pocket knife (1890), Bertoni's DS 19 for Citroën or Le Corbusier's LC4 armchair. French design has its icons and stars: almost everyone knows Charlotte Perriand or Philippe Starck. Some remember Raymond Loewy or Roger Tallon. Yet the French "school", which emerged with industrial art and took shape between the wars, remains little-known. French design combines inventiveness and refinement, and was as successful at Moulinex-Seb as it was at Yves Saint Laurent.

In this dense, well-documented and illustrated volume, which covers fashion, objects and graphic design (posters, illustration, animation...), Stéphane Laurent tells the story of two centuries of French design, driven by continuous and powerful technical innovation, led by engineers-inventors-entrepreneurs as much as by creators. This lively, embodied history includes founding inventions such as Gustave Trouvé's electric tricycle (1880) and the Spad 13 biplane (1918), as well as key moments such as the creation of the Union des Artistes Modernes (Modern Artists' Union) in 1929, and the story of major institutional and political developments.

Master Tolstoy

The Teacher You Don't Want Victoire Feuillebois

For Tolstoy, pedagogy was a vocation, and nothing made him give it up. In this lively essay, Victoire Feuillebois invites us to read or reread Leo Tolstoy's novels in the light of this pedagogical obsession.

At the beginning of the 20th century, people from all corners of Russia and the four corners of the world flocked to seek advice from the most famous living Russian novelist: Leo Tolstoy. Life master, guru or coach: an astonishing destiny for an author who seemed to have done everything in his power to make a mess of his life, and who was well aware that he was an example to no one. Yet there is one area in which Tolstoy wanted to be a master: his school. His life was punctuated by great pedagogical undertakings, which sometimes served as an escape route, sometimes as a laboratory for the writer's work.

To enter Tolstoy's school is to penetrate to the heart of a man's passion, but also to face up to the contradictions of an author who imagined and experimented with a radically original form of learning, for better or for worse. It also takes us back to the effervescence of pre-Revolutionary Russia, at a time when the great Russian novel was enjoying its heyday, and when the country was ravaged by famine and terrorist attacks, riven by fierce intellectual debate and racked by concerns about its identity and destiny.

What is a Film Author?

Art, Power and Division of Labor Jérôme Pacouret

Sociologist Jérôme Pacouret's ambitious study traces the origins of the notion of *auteur* in the film industry on both sides of the Atlantic, and highlights the forms of domination that are exerted on the creative trades of a cinematographic work.

It is often written that the "auteur" of films is an invention of the Nouvelle Vague, or even a specificity of "auteur cinema" as opposed to Hollywood cinema.

By adopting a socio-historical and transnational approach, this book shows, on the contrary, how, from the emergence of cinema in the United States and France, the status of auteur has been constructed and contested by writers, screenwriters, producers and directors. Their struggles and the valorization of authorship are at the root of ways of creating and viewing films, whether mainstream, independent or experimental, but the existence of film auteurs is also at the root of immense social inequalities.

By examining how directors appropriate the value of their works, this book sheds light on the conditions of invisibilization and subordination of their collaborators. The genesis and powers of auteurs are inextricably linked to class and gender relations, which were denounced as early as 1968 and later in the context of MeToo, as well as to forms of racism, nationalism and imperialism.



Jérôme Pacouret is a sociologist of culture and the media and holds a doctorate from EHESS. He is the author of the book *The rights of film authors* (IFJD, 2019). Beyond cinema, his research focuses on intellectual property, the media and social networks. He has been published in various journals.







This dictionary is an indispensable guide to understanding the current evolution of religious practices and their consideration by religious authorities and public policies in light of contemporary legal pluralism.




Ecology and Geography




Byzantium
